1. Collection Cases are only available by special order with a deposit required at time of placing the order.
2. Deposit amount varies according to payment option chosen.
3. Collection case and partial stock supplied at time second payment received with remaining stock supplied progressively as payments are processed.
4. Payments to be made by pre arranged credit card authority.
5. Carry Case & first stock quantity shipped approx 8 weeks from commencement of contract.
